TRANSFER A SUM OF MONEY TO THE GENERAL STABILIZATION ACCOUNT

To see if the Town will vote to appropriate Two Hundred Thousand Dollars and No Cents (\$200,000.00) to the General Stabilization Account (#83000-39900) for reimbursement to the fund from the Water Department; and, to meet said appropriation by transferring said sum from previously certified and available Retained Earnings of the Water Enterprise Fund; or take any action in relation thereto. (Sponsored by the Town Administrator)

The Water Department received a transfer of \$200,000.00 from the General Stabilization Account at the November 10, 2022, Town Meeting to undertake certain capital improvements. The original request was to transfer the funds from the Certified Retained Earnings of the Water Enterprise Fund, but certification of those funds had not been received by the Department of Revenue as of the date of the Town Meeting. Therefore, to meet the capital program of the Water Department, General Stabilization Funds were transferred with the requirement that the Water Department return those funds from Retained Earnings. This transfer returns the \$200,000.00 to the General Stabilization Fund from the Water Department Retained Earning.
