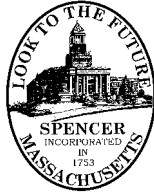

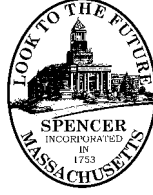

AGREEMENT
Town of Spencer

Agreement made this _____ day of _____ between the Town of Spencer, in the Commonwealth of Massachusetts, herein referred to as the TOWN and

In consideration of an hourly wage (see below) the CONTRACTOR agrees to load and/or haul snow from the public roads of the TOWN as herein provided:

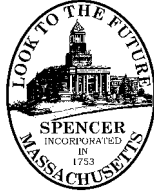
- (1) The CONTRACTOR shall scrape or remove snow from any road within the town limits, public or private, whenever directed by the TOWN through its Highway Department.
- (2) The CONTRACTOR shall acquire and maintain snow removal equipment sufficient for removing snow within a reasonable time. The CONTRACTOR shall maintain and operate said equipment in a safe and workmanlike manner to avoid injuries to persons and damages to properties within the town.
- (3) The Contractor shall maintain insurance in conformance with the attached Insurance Requirements at all times while performing duties under this contract.
- (4) The CONTRACTOR agrees to indemnify and hold the TOWN harmless from any claims for personal injury or property damage to third parties arising out of the contractor's duties and obligations under this contract.
- (5) This contract is effective upon its execution and shall continue until the conclusion of the last snowfall for the 2018-2019 winter season.
- (6) This agreement may be terminated by either party upon the giving of fourteen (14) days written notice.

**2018-2019 Plowing Season
Private Plowing Contractors
Insurance Requirements**

INSURANCE:

The Contractor shall be responsible to the Town or any third party for any property damage or bodily injury caused by it, any of its subcontractors, employees or agents in the performance of, or as a result of, the Work under this Agreement. The Contractor and any subcontractors used hereby certify that they are insured for workers' compensation, property damage, personal and product liability. Insurance coverage shall include Broad Form Liability coverage and Completed Contract coverage and shall name the Town of Spencer as a con-insured certificate holder. The Contractor and any subcontractor it uses shall purchase, furnish copies of, and maintain in full force and effect insurance policies in the amounts here indicated.

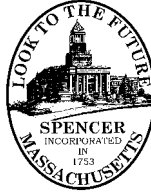
