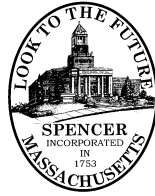

**TRANSFER STATION POLICIES REGARDING NON-PROFIT,
CHARITABLE & POLITICAL GROUPS**

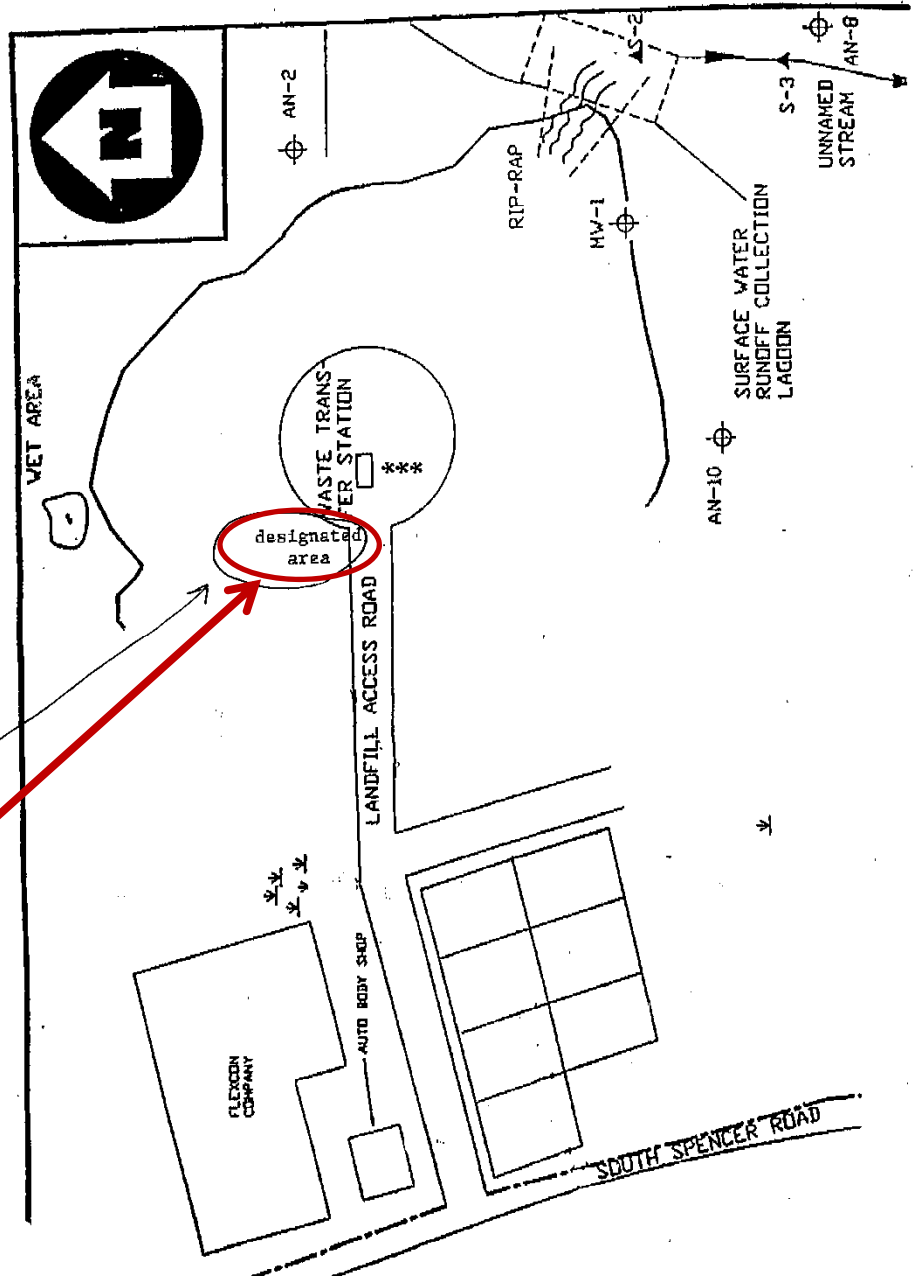
- 1. No persons or groups are allowed on the premise except during normal operating hours.**
- 2. All activities must be confined to the “Designated Area” on the right side of the exit road. (See attached “Designated Area” diagram.)**
- 3. No one less than eighteen (18) years of age allowed on premises without being accompanied by an adult.**
- 4. At no time is any person or group to enter the roadway or impede the flow of traffic. Vehicles must stop by choice.**
- 5. All persons and groups must act in a courteous and professional manner at all times.**
- 6. Any group or individual must leave immediately when requested by grantor or any other duly authorized Town Personnel. (Police, Fire, or Administrator’s authorized staff.)**
- 7. Use is at one’s own risk. Grantee will hold the Town harmless in case of accident or injury. Every person in group that will be on the Transfer Station property/site shall be required to provide a signed Town of Spencer Release Waiver.**
- 8. This form must be posted during event.**
- 9. PLEASE NOTE DESIGNATED AREA IS HIGHLIGHTED IN YELLOW ON BACK OF THIS FORM.**

RELEASE/WAIVER**

myself and my heirs, successors, and assigns, and for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, hereby release and covenant not to sue the Town of Spencer, Massachusetts, and its officers, employees, and agents (hereinafter collectively referred to as the "Town") for any and all liability or claim for personal injury, including death, and property damage, whether caused by the negligence of the Town or otherwise, which may suffer or incur in connection with or arising out of my participation in

the Town of Spencer. I understand that such participation is physically demanding and potentially dangerous and that dangerous conditions include but are not limited to difficult terrain, snake bites, ticks, wild animals, and nondisinfected wastewater, and, therefore, I assume all risk of harm and damage associated therewith. I further agree to indemnify the Town and hold it harmless from all liability for any damages or injuries resulting from my actions while participating in such activities. Furthermore, I acknowledge and agree that my participation is voluntary and unpaid. I understand and acknowledge that I am not entitled to workers' compensation for any injury I may suffer, and I will provide my own health insurance. I expressly agree that this release and waiver document is intended to be as broad and inclusive as permitted by the laws of Massachusetts, and that if any portion is held to be invalid or unenforceable, the remaining provisions are severable and shall continue in full legal force and effect.
