

Chairman Hicks called the meeting to order at 6:00 p.m. and announced that the meeting is being conducted remotely consistent with Governor Baker's Executive Order of March 12, 2020, pursuant to the current State of Emergency in the Commonwealth due to the outbreak of the COVID-19 Virus. In order to mitigate the transmission of the COVID-19 Virus, we have suspended public gatherings, and as such, the Governor's Order suspends the requirement of the Open Meeting Law to have all meetings in a publicly accessible physical location. We are currently meeting with a combination of members present and remote. For this meeting, Chairman Hicks, Vice-chair Woodbury and Clerk Howard are present and Members Berthiaume, Pepe, and are remote, and as such, all votes will be taken by roll call in accordance with Regulation 940, CMR 29.10 of the Open Meeting Law.

Review and Act on Request to Prorate License Renewal Fees for Businesses Required to Close until Phase 4 of the Reopening Massachusetts Plan

Dr. Hicks reported that Ethier's Café and Granville's Pub are unable to open their businesses until Phase 4 of the Reopening Massachusetts Plan and have requested that their license fee be prorated on a 1/12th basis, allowing them to pay only when they are authorized to reopen. He is in favor of this request.

Mr. Pepe asked if the difference in fees could be recovered through the Coronavirus Relief Fund, or if the businesses could apply directly for relief. Mr. Gregory said the Coronavirus Relief Fund is for municipalities and there is nothing in it to cover this situation.

Review and Act Review on Right of First Refusal for MGL Chapter 61A Land (0.5739 acres) owned by George Watson, Jr. on Clark Road and Wilson Road identified as U27-1, parcel A

Mr. Gregory reported that the Conservation Commission voted not to recommend that the Town exercise their right on this parcel.

Attorney Andrea Gordon called in explain that the area is a small piece of land being transferred by Mr. Watson to an abutting property owner for the installation of a new septic system.

Update from the Spencer Cultural Council

Spencer Cultural Council (SCC) Chair John Green informed the Board that the mission if the SCC is to promote opportunities through grant funds received from the State. In 2020 the Council received \$15,000 in grant applications and as result made full and partial payments to various organizations. Those organizations have been unable to execute performances due to the pandemic, however they are able to carry the project over to 2021; if they are unable to perform SCC can request funds be returned.

State Statute limits Cultural Council memberships to two consecutive 3-year terms, therefore new members are needed; they will begin advertising.

Review and Act on Request to Increase Private Plow Rates

Mr. Gregory referenced an analysis of private plow rates from other communities. Highway Forman Eben Butler noted increases in rates from 2018 and asked the Board to increase the rate for each category of plow by \$5 per hour. Mr. Woodbury suggested the frontend loader remain at \$140 per hour; Mr. Butler requests it be increased to \$145 per hour to remain competitive, noting the difficulty with finding plow drivers.

A motion to increase all categories of plows by \$5.00 per hour across the board (Woodbury/Pepe) passed with a roll call vote: Berthiaume-yes, Pepe-yes Howard-yes, Woodbury-yes. Hicks-yes

Review and Act on Proposed Parking Restrictions on Mechanic Street and Regulations for the Use of Mechanic Street Municipal Parking Lot

Mr. Gregory met with Chief Darrin and former U & F Superintendent Krukowski to discuss the use of the municipal lot on Mechanic Street and came up with two recommendations: 1) retain on street parking on the easterly sided only and restrict parking on the westerly side (same side as the parking lot); and 2) no time limits on daytime parking in the municipal lot and overnight parking be available with a permit and fee.

Chief Darrin is in agreement with the recommendations and indicated that the Mechanic Street parking restrictions will make it easier for emergency vehicles to access the street.

Highway Foreman Eben Butler said signage with the rule and regulations need to be clearly posted in the lot and it can be opened immediately. Temporary sawhorses will be set up on the westerly side to inform people to park on east side only. He noted that some residents have large trailers and commercial vehicles and should not be allowed to park in the lot.

Dr. Hicks suggests placing a limit on commercial vehicles up to 1- ton and not allow trailers.

Mr. Woodbury said the lot is not meant for landlords to offer tenant parking. Mr. Pepe agreed noting that the goal is to offer parking for retail shops and restaurants in Spencer.

A motion to allow one-way parking on the east side of Mechanic Street only (Woodbury/Pepe) passed with a roll call vote: Berthiaume-yes, Pepe-yes Howard-yes, Woodbury-yes. Hicks-yes

A motion to open the municipal parking lot with a commercial vehicle limit and not to offer commercial parking spaces, and to re-assess in six months (Pepe/Woodbury) passed with a roll call vote: Berthiaume-yes, Pepe-yes Howard-yes, Woodbury-yes. Hicks-yes

Review and Act on Coronavirus / COVID-19 Response

Dr. Hicks asked about the cause of the recent spike in cases. Health Agent Daoust said there are no specific causes and she is unaware of any large events having occurred. The Town is now at 18 active cases, which may be a result of being indoors more.

Review & Act on Governor Baker's COVID-19 Order No. 50 to extend the Date for Outdoor Dining

Mr. Gregory reported that the Governor's Order No. 50 allows the Board to extend the previously approved outdoor dining license to a date certain, or 60 days beyond the State of Emergency.

Dr. Hicks noted that the Black & White is the only restaurant with outdoor dining.

A motion to extend outdoor dining to 60 days beyond the State of Emergency (Woodbury/Howard) passed with a roll call vote: Berthiaume-yes, Pepe-yes Howard-yes, Woodbury-yes, Hicks-yes

Discussion on Governor Baker's COVID-19 Order No. 54 Regulating Gatherings

Mr. Gregory reported that Section 4 of Governor's Order No. 54 requires that all physical gatherings end by 9:30 pm.

A motion to follow governor's guidelines on Order No. 54 (Woodbury/Pepe) passed with a roll call vote: Berthiaume-yes, Pepe-yes Howard-yes, Woodbury-yes. Hicks-yes

Discussion on Reopening Town Hall

Chairman Hicks said reopening Town Hall will be discussed at a later date as the Coronavirus cases are increasing. The Board agreed.

Four individuals have volunteered to serve on the seven-member committee: Pat George as Private Internet User Member, Pamela Woodbury as Elderly Community Member, and two citizens-at-large members: Matt Dicheio and Danielle Gebo. Aaron Keys volunteered to be the Spencer Cable Access Member. There are two spots remaining: a member of the Finance Committee Member and Spencer-East Brookfield Regional School District (SEBRSD).

Mr. Gregory will contact Dr. Paul Haughey for the SEBRSD representative.

The Board will review membership at their next meeting.

Mr. Gregory advised the Board that since Interim Town Clerk Lisa Johnson does not live in Town, a resident of Spencer mush be appointed as temporary Town Clerk to record votes at the Town Meeting.

Dr. Hicks indicated that this will be on the Board's Special Meeting at on November 12th at 6:30 pm.

Update on U & F Superintendent Position Opening

Mr. Gregory received four resumes. A screening committee will be set up.

Update on ODIS Director/Town Planner Position Opening

The Town Planner Screening Committee met last week and will hold a second meeting on November 10th.

Citizen's Input

Josephina Sullivan, 17 Greenville Street said she owns shop on Mechanic Street and is not in favor of renting parking spaces, noting the municipal lot should be reserved for shop customers and signage should be visible. Dr. Hicks said signage will be placed by the Whitco driveway area.

Board Member and Staff Comments

Mr. Butler noted that the Water Department is struggling to serve residents with the building closure and asked the Board to open the glassed-in foyer area. The Board will review this request at their November 23rd meeting.

Ms. Berthiaume announced that the 2020 Christmas Parade of Lights has been cancelled due to COVID-19.
