6:05 p.m. - Public Hearing Review & Act on New Alcohol License Application of Adel Abdelmasih, d/b/a as Alpha Mart, 160 Main Street for a Wine & Malt Beverages License

Chairman Woodbury opened the hearing at 6:05 pm.

Adel Abdelmasih, owner of 160 Main St. is opening a convenience store at that location and would like to obtain a license to sell beer and wine.

There were no questions from the public or the Board. All paperwork is in order to submit the application to the State. If approved, proof of TIPS certification and liquor lability insurance must be obtained prior to issuance of license.

6:30 p.m. National Grid Pole Hearing - Review & Act on Request for May Street - Plan # 27165477

The hearing opened at 6:42 pm. All were in favor.

National Grid representative Kim Tavalaimola indicated the request is to add a new pole and anchor on May Street to replace an existing pole and a guy wire on a tree that is being taken down.

Mr. Monette noted that the Highway Department approved of the new location.

There were no comments from the public. The hearing closed at 6:48 pm.

Review Conceptual Design for Green Space West of Sugden Building

Jason Dubois presented a conceptual plan for green space on the west side of the Sugden building which includes leveling the area, adding a retaining wall, paver patio with granite seating benches, and landscaping trees. He is also proposing another green space area near the Library in the shape of a book.

Mr. Monette spoke with Library Director Cheryl Donahue and said she is looking for additional seating space in that area and he will work with her on a proposal. Dr. Hicks asked about the estimated cost for construction. Mr. Monette said the plan needs to be accepted first and would then go out for bid.

Administrator Gregory said a public hearing will be held to obtain input from citizens.

Act on Senior Health Insurance Renewal for CY2019

Mr. Gregory reported that the Town received a favorable quote from MIAA for a Medicare Indemnity plan. The proposal is to eliminate the existing Fallon Senior Plan and the Tufts HMO and move into a Medicare Indemnity Plan with MIIA (Blue Cross Blue Shield) called Medex 2. Moving to this plan eliminates current issues with carriers not honoring certain doctors/hospitals and also provides considerable savings to the Town and the retirees. The Insurance Advisory Committee voted for this recommendation.

Administrator Gregory received Town Counsel opinion that existing lease agreements will remain in place with the new building owner. Developer Peter Venuto confirmed he will acknowledge the lease obligation under the law and leave open the opportunity for negotiations if lessee wishes to change their agreement.

Mr. Venuto arrived and said he will work within all lease expiration dates and is looking forward to begin negotiations on the project.
