
Craig Nussey, 101 Hastings Road said he is having a water issue on his property from a berm that needs to be replaced. Mr. Gregory will check into the issue.

Bill Shemeth was pleased to see that Spencer Cable Access (SCA) plans to name the new Control Room after Al Shedyak and thanked Mr. Shedyak for his service on the Finance Committee and the SCA. He also mentioned that sewer rates will increase and the burden will fall on sewer users at an estimated \$1,000 increase per user, which is disproportionate in comparison to other services. He asked the Board to encourage the Legislators to obtain funding for these projects.

Discussion on the Increase in Sewer Rates

Dr. Hicks is the liaison to the Sewer Commission and said issues at the Sewer Plant, including the pollution of the seven mile river, need to resolve and upgrades will be costly.

Sewer Commissioners Frank White and Larry Dufault were present. Mr. White said the sewer uses will see an increase of \$32 per quarter at this time. Mr. Dufault said the current estimate for the upgrade is \$26 million. This has been an issue since 2012.

Currently there are no grants provided for sewer infrastructure. The Sewer Commissioners will hold a future meeting with State Legislators to see if any type of funding assistance can be obtained.

Town Administrator's Report

May 2, 2019 Annual Town Meeting Update

Chairman Woodbury will assign Warrant Article motions to the Board.

Mr. Gregory reported that the Planning Board proposed changes to the Zoning Articles 31, 32, and 33 and an amendment at Town Meeting will be necessary to incorporate the changes. Additional analysis will take place with the Moderator.

Moderator Shemeth said he needs additional information from Town Counsel on the Citizen's Petition and whether people can vote on the Petition. Mr. Gregory said some towns declare it inactionable and don't allow discussion to take place. Town Counsel advised allowing voters to deliberate on the Petition.

May 14, 2019 Annual Town Election Update

The only contest is for Constable.

Board Liaison Reports

Mr. Pepe said the EDC will meet to discuss downtown revitalization and collaborating with the Celebrations Committee.

Ms. Berthiaume will meet with the American Legion on the 100th Anniversary Celebration scheduled for June 15th.

Dr. Hicks noted the discussion at the meeting with the SEBRSD and DESE with school funding increases being unsustainable each year due to the outdated Chapter 70 Education Funding Formula which provides only \$20 per student for the District, while Worcester receives \$600 per student. Residents cannot afford a huge tax increase to keep up with the increases.

Citizen Input

Mr. Shemeth noted the disagreement between DESE and DOR, with DOR acknowledging the Town cannot afford these increases.

Board Member and Staff Comments

Mr. Gregory noted the takeaway theme from the SEBRSC presentation was that Spencer can afford to pay the additional school funding and then a slide went up showing the excess tax levy for the Town was only \$1,200.

Mr. Pepe agreed and said increasing taxes is not the answer.

Mr. Monette pointed out that most communities are experiencing financial pressure from the increased cost in school funding and said it's time to unite to see what can be done. Dr. Hicks said it may take another lawsuit to the State to see any changes.
