Sewer Systems Upgrade

Still have a lot of work to do in order to identify the areas of concern to help mitigate the I&I (inflow /infiltration) so we can support the expansion of development of the community. Per Town Administrator the Town councils believe that it's expired.
- <u>Land use Ordinance</u>: Review draft propose land use from Wright-Pierce. If we adopt the land use great idea to lose or repeal the moratorium
- Grease Trap: Most towns show that the ordinance falls under the Board of health.
