- Chemical Bids for Lime, Polymer and Aluminum. Larry motion to approve the amounts and fees for the chemical bid that was open on 6/8/23, second by Frank, all in favor, Francis Jr. Roll call vote: Larry-yes, Frank-yes, Francis Jr.-yes.

• <u>Valley Street</u>: Sewer pipe repair originally voted bid for \$114,750.00 6/7/2023. Adding two more manholes to be installed. Sewer Superintend would like an itemized list of exactly what the Sewer Dept. supplied to Ludlow. Added Sewer Lateral Repair and Sewer Main Collapse Repair. Larry motion to accept Ludlow reducing the sewer main collapse repair amount, so the total amount that we will approve is \$133,882.74, second by Frank, all in favor, Francis Jr. Roll call vote: Larry-yes, Frank-yes, Francis Jr.-yes.

- <u>18 Summit Street</u>: Owner is looking to add a second bathroom in the basement and two bedrooms. Need to fill out a sewer permit application for additional flow and the I&I fee for two bedrooms is \$3,520.00.
- <u>17 ½ Greenville St</u> Owner is looking to add two bedrooms. Sewer Commissioners review plans. Recommend that the sewer lateral be inspected before the Commissioners approve it. Would need to hire a private company to inspect. Would need to fill out sewer permit application for additional flow and the I&I fee for two bedrooms is \$3,520.00. Larry motion to approve the additional two bedrooms, conditioning on the lateral to be independent and not shared, second by Frank, all in favor, Francis Jr. Roll call vote Larry-yes, Frank-yes, Francis Jr.-yes.
- <u>22 Pope St</u>. Owner is looking to add one bedroom. Need to fill out sewer permit application for additional flow and the I&I fee for one bedroom is \$1,760.00. Larry motion to approve the one bedroom with the I&I fee, second by Frank, all in favor, Francis Jr. Roll call vote Larry-yes, Frank-yes, Francis Jr.-yes.
- <u>43 High St</u>. Requesting abatement on Sewer. Pipe burst outside of the home in a crawl space not in the basement. No water ever went into the home, just into the soil. Larry motion to approve the rebate as the result of sewer pipe burst to bring usage down to 4482 2000 = 2482, second by Francis Jr, all in favor, Frank.
- <u>42 Main St</u>: Single family only have seven bedrooms. Question on how many bedrooms. Falls under the change of use. Would need to fill out sewer permit application for additional flow and the I&I fee for four bedrooms is \$7,040.00. Francis Jr. motion to approve for four bedrooms, Larry second, all in favor, Frank. Roll call vote Larry-yes, Frank-yes, Francis Jr.-yes.
