Budget & Capital Items:

- <u>Ludlow Construction</u>. Sewer main collapse repair on Valley Street. There was a crack on the sewer pipe. The Sewer Dept. has video on this, it shows a spider crack. Sewer did offer to supply the parts for the repairs. Ludlow Construction would like the Sewer Commissioners to authorize payment as that failure, was not caused by negligence from the Contractor, cost for repairs is \$4,495.11. Will be reviewing the video with Ludlow. Sewer Commissioners would like to table until next meeting.
- <u>Septage late fees</u>: Sewer Commissioners discuss adding septage demand fees. Would like to table until the next meeting.

- <u>Rapscallion</u> purchased and installed flow restriction fittings. Calibration was done a few months ago.
