Vote to approve Meeting Minutes for September 15, 2021.

Superintendent James LaPlante Reports:

Commissioner expressed interest in the contractor that will be doing the installation, calibration of the equipment and maintenance.

Budget & Capital Items:

- <u>Manhole covers</u>: Three manholes that need to be raised. Some parts are in stock. Sewer Superintendent would like EM Thibault Excavation to do the work because he has a bid with the Town. Would like to do ASAP. Larry motion to higher EM Thibault Excavation to raise the manhole for a cost of \$5,000, seconded by Frank, all in favor, Mike. Passed 3/0 with a roll call vote Larry-yes, Mike-yes, Frank-yes.
