Sewer Systems Upgrades:

- Lake Street School I&I removal. New built 41 bedrooms residential with 2 bedroom manager apartment at 110 gpd per bedroom 43 x 110 = 4,730 gpd. Still need to determine an I&I removal before we can allow additional flow.
- WWTP garage built won't be starting until spring of 2020.
- MCWT Grants (Mass Clean Water trust) some of the work can be funded through the grant. Including the software for the video pipeline inspection system.
- Review Masterman's quotation for MIIA safety equipment.
