Main St/ Greenville St Water Main Looping Project updates: Greenville Street is done. Easement line is done. All services are done. Shutdowns to cut into T's are complete. Property owner at 19 Greenville Street approved grass being put back instead of gravel road.

<u>Update status on Casey St water main repairs/replacement:</u> Pipe and material has been ordered. Road will be patched for the winter. - <u>69 Maple St</u>: Son-in-law called stating in-laws have been very ill and in the hospital so they have been unable to pay the bill. Requesting payment plan. Steven motioned to accept payment plan of \$400 per month. Frequency and dates to be worked out with Senior Clerk, Kim Snyder, seconded by Eben.
- <u>15 Smithville Rd</u>: Owner is requesting payment plan. Hardship letter. Eben motioned to accept agreement, seconded by Norman.
- <u>55 Temple St</u>: Owner is requesting payment plan. Hardship letter. Eben motioned to contact owner to arrange a smaller payment agreement than owner requested, seconded by Norman.
- <u>117 Main St</u>: Unpaid water bill. Brenda & Deb called several times inquiring about payment. They said they would make payment but have not yet. Eben motioned to terminate services on 10/8/19 if payment has not been received, seconded by Norman.
- <u>Bixby Rd</u>: Made payment of \$6,000 on 10/1. They said they will be paying the remaining \$12,000 by the 15th of October. Eben motioned that if payment is not made by October 15th, services will be terminated, seconded by Norman.
- <u>31 Temple St</u>: Owes payment of \$690.96. Bounced a check. Will pay on 10/3. Eben motioned by allow owner to make payment by October 3rd, seconded by Norman.
