The commission wants him to find out where the wells are on the neighbor's property, and submit three sketches of the plan. The manure will be stored in the paddock until November 14, 2018.

**Holmes Street Solar:** Ken Lacourse had revised drawings on his latest proposal. Graves Engineering reviewed the drawings. The proposal is to install a new gutter inlet with a catch basin grate and connect the gutter inlet to DCB-A (a single-grade catch basin).

<u>Wire Village School Detention Basin:</u> Eric Hevy sent photos and updated the commission regarding the progress with the vegetation removal within the water detention ponds. The Spencer Highway Department was able to make two swipes around two detention ponds and one around the west side of the building. He made arrangements for the Worcester County Sheriff's Office Community Service Program to come do clean up. Mr. Hevy's goal is to maintain those areas every few years and use the WCSO Community Service program again.
