Mrs. Charlesworth stated that they chopped down four trees themselves and were not aware that they needed a permit. Ms. McLaughlin read the inspection report. Warren Snow stated that there were 2 logs in the water. Mrs. Charlesworth said that the bridge was there when they moved in. The Commission recommended planting 4 native trees to replace the ones they took down. The condition would be to plant the trees by May 30, 2019. Heidi Olivo recused herself from this meeting.

# Property: 4 Bellevue Drive, Spencer, MA

Mary McLaughlin read the inspection report. Fred Trifone from Jalbert Engineering presented the plan. Mr. Trifone discussed the work that was to be done. There are no Conservation issues.

Lisa Barylski, an abutter, had some concerns regarding the addition. Ms. Barylski stated that there have been ongoing water problems for years at her address. There is a catch basin near the neighbor's property basin that nobody cleans. Ms. Barylski is afraid the work next door will cause more water to enter her property. The fire department has had to come out to her property to pump out all the water in her basement. Ms. Barylski stated the water is destroying her home. Ms. Barylski wants to know who she needs to go to get help with the water problem. Charlie Bellemer asked is anyone knew where the catch basin drains to. Mr. Barylski would like to see the plans where the pipes go underground. Warren Snow asked if she is part of the Lake Association, she is not. Heidi Olivo suggested having a conversation with her neighbors about cleaning out the catch basin. It is a private road so therefore it would be a Civil Matter.

# **Other Business:**

**64 Borkum Road:** Levon Kachadoorian from Everlast Nursery attended with Pamela Simonis. Mr. Kachadorian showed the commission how far away the wells are on the plans. Warren Snow wanted to know if the manure was still near the stream. The commission was concerned that the manure would flow into the stream. Mr. Kachadoorian stated that it is beautiful soil and it does not flow into the stream. He said it would be a mess if you moved it. The commission suggested planting perennials in that area where the manure was located.

A motion to accept the plan with a contingency to call the Conservation Commission. Plant perennials that are not invasive by June 15, 2019.

2 & 3 Valley View Drive: Charlie Bellemer went to the re-inspection. Mary McLaughlin read the inspection report. William Klansek, the applicant, wanted to know why all the money needs to be retained. Mrs. McLaughlin stated that because the grass is not grown, you could have gullying and washouts. The grass prevents the stormwater from getting to

the wetlands. It stops the erosion from happening. It looks like the problem has been rectified. The commission agreed to reimburse \$5, 234.00. Once the grass has grown, the rest of the stormwater bond money will be reimbursed.

A motion to reimburse half of the money (Snow/Bellemer) 4/0

12 Pointe Eastalee: Tony Bonaventura presented the plan regarding the well.

All in favor to agree to use a drywell and/or pipe to catch the overflow from the artesian well (Bellemer/Olivo) 4/0

**137 Wilson Avenue:** Mary McLaughlin read the letter regarding a complaint about a berm. The plan was already approved prior to this complaint.
