Other Business:

Thompson Pond Road culvert complaint: An anonymous letter was dropped off at ODIS on 3/13/19, expressing concern about lack of sediment controls at the proposed culvert replacement. Ms. Washburn met Nathan Gottier of Stanec at the site. He agreed to stabilize all of the exposed soils upon completion of the culvert replacement.

<u>45 Kingsbury Road:</u> Thomas Abraham was present regarding the Notice of Violation. He didn't realize he was working in the 100-ft buffer zone. He was cleaning up his yard. He got a permit to burn the brush pile. The Commission scheduled a follow-up site walk.

102 Chickering Road Stormwater Bond question: Matt Schold wanted to know if he could get the bond released, because it is up for renewal. Ms. Washburn said that the Order of Conditions requires a Certificate of Compliance in order to release the full amount.

<u>Solar Farm Vegetation:</u> Margaret Emerson wanted to discuss what should be planted around the solar farms. There was a discussion on using herbicides and pesticides around the solar panels. Ms. Washburn stated that bittersweet would inevitably climb up the panel supports if they do not use some form of chemical treatment. Ms. Emerson said that some of the other towns have put a cap on the number of solar farms. The Commission discussed the idea of a requirement to set aside an equal amount of forest when putting in a solar farm. There was also discussion about a surcharge for solar farms.

Thompson Pond: OofC for nuisance aquatic vegetation control, DEP #293-0742: Marty Nathan had a question regarding section B from the Order of Conditions that was issued in 2010. Mr. Nathan was seeking clarification regarding whether updated

bathymetry maps are required under the OofC that was extended on 2/27/19. An updated bathymetry map was submitted with the recent request for extension of the OofC. The Commission reviewed the terms of the OofC and agreed that the OofC required that only one bathymetric map was required, as per page 8A in the OofC. The OofC does not require that bathymetric maps must be submitted when requests for extensions are submitted.
