4.0 PUBLIC HEARINGS:

Item 4.1. 129 Wilson Ave. NOI: This application was filed as a result of a NOV from my office and a vote of the Commission to require an NOI be filed. The issue concerns leaves placed in the stream channel at this address, thus impacting bank, LUWB, and flood hazard zones. I believe that removing the bottom layer of the leaves etc. will potentially do more damage than leaving them there and therefore I would recommend that the Commission should vote to grant the Orders to allow removal of the all but the bottom 6" of the debris and that no more be allowed to be deposited, unless via nature. All removal should be done by hand vis-à-vis by machine.

When the DEP number is issued, I would recommend the following special conditions: 27-30, 34, 37,46, 47, 50, 52 & 53.

Item 4.2. Phyillis Brewer, E. Charlton Road NOI: This permit is for the now infamous Jenese property/violation on E. Charlton Road. There is a significant wetlands delineation involved and have thus requested the applicant to forward a copy of the application to a peer reviewer. I would recommend the Commission take no testimony/action until we have the completed peer review. In addition, the NOI # has not been issued.

As a side note, there has been no contact with Mr. Moore who was also issued an enforcement order on this property. I have generated numerous pieces of correspondence to him and have not heard anything.

5.0 OTHER BUSINESS:
