The applicant's representative, Samantha Robinson from Green Hill Engineering, joined the hearing. There is a current cesspool that they plan to abandon and fill in and install a new 1500-gallon septic tank. The leach field will be on the side of the driveway. Ms. McLaughlin said that when the Commission went for a site visit, there was grubbing all the way down to the brook and along the back. There is a debris pile behind and to the right of the pool within the buffer zone. There is a 200-ft buffer within the riverfront and a 25-ft no touch zone. Mr. Williams said there was a couple of outhouses they had to remove. They had no idea that there was a problem with the debris pile. They were trying to pick up the mess. The Commission told the applicant they need a restoration plan for treatment of the debris pile and revegetating the grub area. They need to hire a Wetland Specialist to help with the plan. This will be done as an Enforcement Order.
