Update on Financial Policies Document - Mary Braney

A feasibility study is in process for (re)adopting/accepting amended/rewritten articles and Bylaws.

Initial Town Administrator Budget Presentation - Bill Ross

Stated that the general fund budget (which he will send to committee via email) has no major changes. Mr. Ross stated he used the governor's figures to consider the amount of local aid from the state and presented/hi-lighted areas such as changes with regard to contract salaries, hours that were added back into the budget for the town hall and library; monies allotted for a full time town accountant, of which Mr. Ross strongly suggested and firmly believes is a very important part which strengthens the internal operating controls and support to fiscal affairs of the town, an additional highway person and the schools request for significant funding above the Minimum Local Contribution (MLC) in order to meet the needs for special and regular education, as the district strives towards reinstating and creating positions.

A study of the library heating/hvac system) has been done, which a three (3) year plan to redo the system...the system is beyond being able to extend its life with patch-work maintenance; it is extremely necessary that the system is replaced.

Will be releasing *Request for Proposal* (RFP) for the sale of Lake Street School.

Final comment made was with regard to the solar farm to be installed by Citizen's Energy Group, on the transfer station site, projected to generate \$320,000.00 revenue.

Update on SEBRSD budget request

Mr. Ross discussed the "state of the school district; and the underlying issues, such as the district's special and regular educational requirements and the need for approximately half a million dollars increase; attributing the increase to the Minimum Local Contribution, 12 additional positions and the lack of funding from the state. The budget remains a work-in-progress.
