- a) Economic Management Committee (Chris Woodbury): did not attend meeting but reported that he had read the committee's minutes and the committee was exploring the opportunity to apply for available grants for further development of the downtown area.
- b) **SEBRSC** (Mary Braney): Attended a meeting in which the school committee (having previously met with the Board of Selectmen and Finance Committee) submitted their FY2019

budget, which was \$19,000.00 more than the Board of Selectmen & Finance Committee anticipated. School committee members reviewed, defined and reallocated funds, prioritizing the most important needs for their budget; such as, the cost for employee heath insurance was lowered by a savings through a larger deductible and a reduced the amount, previously budgeted, for the legal expense line item were two of the area(s) where the school committee was able to trim expenses. The town administrator reworked accounts (on the town side) in order to fund \$19,000.00 needed for the school district budget.

Also discussed was to establish a Special Education Stabilization Fund; to be voted on at the annual town meeting May 3, 2018.

<u>Any other</u>: Mr. Shemeth discussed the steps being taken for Spencer, by the Board of Selectmen, to become a "Green Community" and stated that the Board wanted more time to consider and further discuss being designated a "Green Community."

Mr. Gregory stated that *Central Mass Regional Planning Commission* has offered the Town of Spencer \$7,500.00 in assistance to apply for "Green Community" status, but mentioned that the town needs to satisfy certain criteria in order to be considered.; Spencer's estimated grant amount is \$155,000, when "Green Community" status designation is obtained.. Also, Spencer becomes

eligible to approximately \$240,000.00 in competitive, state-wide energy efficiency initiatives, once designated as a "Green Community." More information to come when obtained and will be presented at public informational meetings.
