> Hamadryad, LLC- Donnelly Road

Mr. Dell'Aquila explained that the location of the ANR is 68/70 Donnelly Road, Spencer Assessor's Map R36-29 & R36-29-6 and the applicant owns both lots and has submitted a lot line adjustment for the above-referenced lots. The ANR plan as submitted complies with the requirements of Spencer's Subdivision Regulations. In addition, Mr. Dell'Aquila explained that the applicant will be coming back for a common driveway and is currently going through the process with the Conservation Commission. Ms. Shiver asked about the driveway easement and Mr. Dell'Aquila said it is for a future application.

Jim Hansen, Hamadryad, LLC, was present for the meeting and discussed his intent to build houses on both lots but because of the wetlands the parcels need to be developed together. Mr. Hansen approached the board to show them future plans for the lots. Furthermore, Mr. Hansen explained he is meeting with the Conservation Commission and the septic/well have been approved.

There was much discussion in regards to the future driveway and easement, which, will all be discussed once the applicant applies for the common driveway application, and the tech review takes place with Conservation and the Highway Superintendent.

Ms. Shiver asked what happens to Sandstrom's lot and Mr. Hansen said it doesn't change. Ms. Shiver asked about #12 on the application in regards to the application checklist and the answer N/A. Mr. Hansen said he did not fill out the application. Mr. Dell'Aquila said he checked everything and the applicant is all set.
