- <u>9 Holmes St</u>: Home was demo in 2017. Resident likes to rebuild, but wants to know if he has to pay another connection fee or could it be waived (3 bedroom). Motion by Mike to waived fee, but lateral needs to be fixed; inspected and video, second by Frank and in favor Larry.
