- ARTICLE 8. To authorize the Commissioners to continue to retain legal counsel to represent the District in any matters concerning the District which the Commissioners deem to be appropriate and consistent with funds so authorized.
- ARTICLE 9. To authorize the Commissioners to continue to retain the services of professional firms to do such work as may be necessary and consistent with funds so authorized.
- ARTICLE 10. To vote on the petition by the assessed owner of the property now included within the Stiles Lake Water District, being shown on Town of Spencer Assessor's Map as Parcel OR15-00009, located at 66 GH Wilson Road and described in Worcester Registry of Deeds in Book 40853, Page 0235, to be removed from inclusion in the Water District due to court decision affecting the parcel's access to the District's water and requesting abatement of the Stiles Lake Water District tax assessed on the property and collected by the District for the 3<sup>rd</sup> and 4<sup>th</sup> quarters only of the fiscal year ending June 30, 2024.

ARTICLE 11. To discuss any other business as may properly come before the meeting.
