a. 6:16 p.m. Opened the Public Hearing for the Notice of Intent for Jeremy Paz-Sirvas

Property: 23 Pine Acres, Spencer, MA DEP#293-1054

Mark Farrell, from Green Hill Engineering, discussed the septic repair upgrade for an

Conservation Commission Minutes April 26, 2023 existing cottage. Mr. Farrell said the property is in the riparian zone, but it was in existence prior to the Rivers Protection Act. The proposed plan is to put the septic far away from the brook, up against the property, and away from the pond. The cesspool will be abandoned and there will be a raised leach field away from the lake. There will be a designated stockpile. Ms. Vivier would like there to be two DEP signs posted. One sign should be posted by the road and one sign should be posted by the lake.

4. Agent's Update:

- a. <u>Hastings Road:</u> Ms. Vivier spoke with the property owner last week. She sent all the photos that Mr. Bellemer took to the highway department. The contractor came in on Monday and told Ms. Vivier that straw bales are on back order. Ms. Vivier told him that they need to clean up the trench, replace the bales, dig out the silt and trim the grass that's growing. It needs to be maintained all season. She told him to get extra bales and maintain them. It is the responsibility of the property owner to maintain erosion. Mr. Bellemer suggested putting a trench at the end of the driveway to act like a settling basin. Ms. Vivier said that if at the end of the project the stormwater is not performing, they need to submit new plans.
- **b.** <u>54 R Jones Road:</u> Carl Leinonen called Ms. Vivier regarding the letter she sent. The piles of dirt they observed were a peat moss mix used for planting. He will put some wattles around the piles until they use them.
- **c.** Westland Drive: Ms. Vivier said that we have not received anything back from all the letters/fines we have sent. It looks like someone is maintaining it. They are scheduled for court next month.
