Public Hearing: Continuation from the Tuesday, June 13<sup>th</sup> meeting- Special Permit—Applicant/Owner: Julie Peloquin, DBA: Black Tulip Massage; Location: 7 Terkanian Drive, Spencer Assessor's Map R32-25. The applicant is seeking a Special Permit under Sections 4.8.3.A.2 (Use of Residence for Business Purposes/ Customary Home Occupation) of the Spencer Zoning Bylaw to run a professional massage therapy business inside home, with off street parking, and no signage. The property is in the Rural Residential (RR) zoning district.

Julie Peloquin, 7 Terkanian Drive, was present at the meeting and had nothing to add to the application. Mr. Collette asked if she would be using one room and Ms. Peloquin said that she would be using one room on the first floor, rear side and the square footage is 10 x 10. Mr. Collette asked if she would be requesting a sign in the future as she is allowed to have a sign. She said initially she would be keeping it to family and friends. Ms. Bedford asked to add a condition to the decision language that a sign is allowed in the future.
