1. Open Meeting – Mr. Collette was acting chair and opened the meeting at 7:19 pm.

2. Special Permit (Renewal) – Applicant/Owner: Robert & Margaret Moschini (Royal Crest Farm). Location: 30 Howe Road, Spencer Assessor's Map R23-25. The applicant is requesting a Special Permit Renewal under Section 4.8.6 of the Spencer Zoning Bylaw to continue a gravel removal operation. The property is located in the Rural Residential zoning district.

Robert Moschini, 30 Howe Road, was present for the meeting and said the gravel pit was a small part-time operation mostly used for topsoil and compost. Also, Mr. Moschini said there 1 year is equal to 1 day at Bond gravel pit. Mr. Collette asked where all the work was being done in correlation to the map provided. Mr. Dell'Aquila pointed out that on his memo to the board members there was an initial configuration from 2009 to 2017 and that section B is where all the work is being done. Mr. Stolarczyk asked about section C and Mr. Dell'Aquila said C1, C2, and C3 have been combined and are now just C. Mr. Collette asked what the life is before moving on into another section and Mr. Moschini said five years.

Mr. Dell'Aquila explained that Margaret Washburn inspected and according to her inspection sheet there was no noted issues. Additionally, the gravel pit has been inspected the past five years with no noted issues. Mr. Dell'Aquila asked the applicant to provide a short annual report to discuss the amount of gravel removed with the material and section, which, shall be due on September 15th of each year. Mr. Collette asked why that date and Mr. Dell'Aquila said that Ms. Washburn goes on inspections in October and would like the annual report before she does her inspections for comparison.

There were no abutters or public for open discussion.
